Attini Internet Privacy Policy

We understand that privacy is an important issue for users of, and visitors to, the Attini Internet site www.attini.io. The following information is designed to help visitors understand what information we collect, and how we handle and use the information after that.

Attini privacy principles:

- Notice to individuals to identify the purposes for which Personal Information is collected, used, retained and disclosed.
- Choice and consent available to individuals with respect to the collection, use, retention and disclosure
 of Personal Information.
- Collection of Personal Information for the purposes identified in the Notice.
- Use, retention and disposal of Personal Information as identified in the Notice and for which the individual has provided Consent.
- Review of Personal Information for individuals to access their information and ensure it is correct and accurate.
- Disclosure to third parties of Personal Information for purposes identified in the Notice and for which the individual has provided Consent.
- Transferring data to other countries in a legal, secure and auditable manner.
- Security for privacy of Personal Information to help protect against unauthorized access and use.
- Quality of Personal Information to ensure that reasonable steps are taken to ensure Personal Information is correct and accurate.
- Accountability and Privacy by Design to ensure compliance with the privacy framework.

Information collection and use

The data controller is Attini, Stockholm. We may collect information from our users at several different points on our website. Information may be stored on our servers or that of a third-party server on a secure basis. We may collect your personal information as an individual for various purposes, such as:

Contacting employees of our customers, prospects, partners and suppliers

In our relationship with customers or prospects, partners and suppliers, they also provide us with business contact information (such as name, business contact details, position or title of their employees, contractors, advisors and authorized users) for purposes such as contract management, fulfillment, delivery of products and services, provision of support, invoicing and management of the services or the relationship.

Visitor information

We may register individuals visiting our sites, locations and events (name, identification and business contact information) and use camera supervision for reasons of security and safety of persons and belongings, as well as for regulatory purposes. If we hold an event, when you register for an event, we may collect information (online or offline) in relation to the event organization, and during an event, such as participation in sessions and survey results.

Marketing

We may use information collected from users for sales and marketing purposes, including email marketing. We may combine this information with data obtained from other sources to help us improve its overall accuracy and completeness, and to help us better tailor our interactions with users. Users may choose not to receive marketing materials by unsubscribing.

Responding to a request for information, order or support

We collect your name and contact information, details about your request and your agreement and we may include client satisfaction survey information. We retain such information for administrative purposes, defending our rights, and in connection with our relationship with you.

Subscriptions

If a user wishes to subscribe to Attini information via our website such as press releases, we ask for an email address. We will use this e-mail address to send the requested information.

How to subscribe and unsubscribe: Users may open or cancel subscription(s) of press releases at any time by so indicating via email.

Orders and surveys

We may request information from users in order forms. Here a user must provide contact information (such as name and shipping address) and, sometimes, financial information (credit card number, expiration date). This information is used for billing purposes and to fulfill customer orders. If we have trouble processing an order, this contact information is used to get in touch with the user.

From time to time our site may request information from users via surveys. Participation in these surveys is completely voluntary, and the user therefore has a choice whether or not to disclose this information. Information requested may include contact information (such as name and address), and demographic information (such as gender, age, level of education). Survey information will be used for purposes of marketing, monitoring or improving the use and satisfaction of this site.

Third-party services

We may partner with another party to provide these or other specific services. When the user signs up for these services, we will share names, or other contact information that is necessary for the third party to provide these services.
